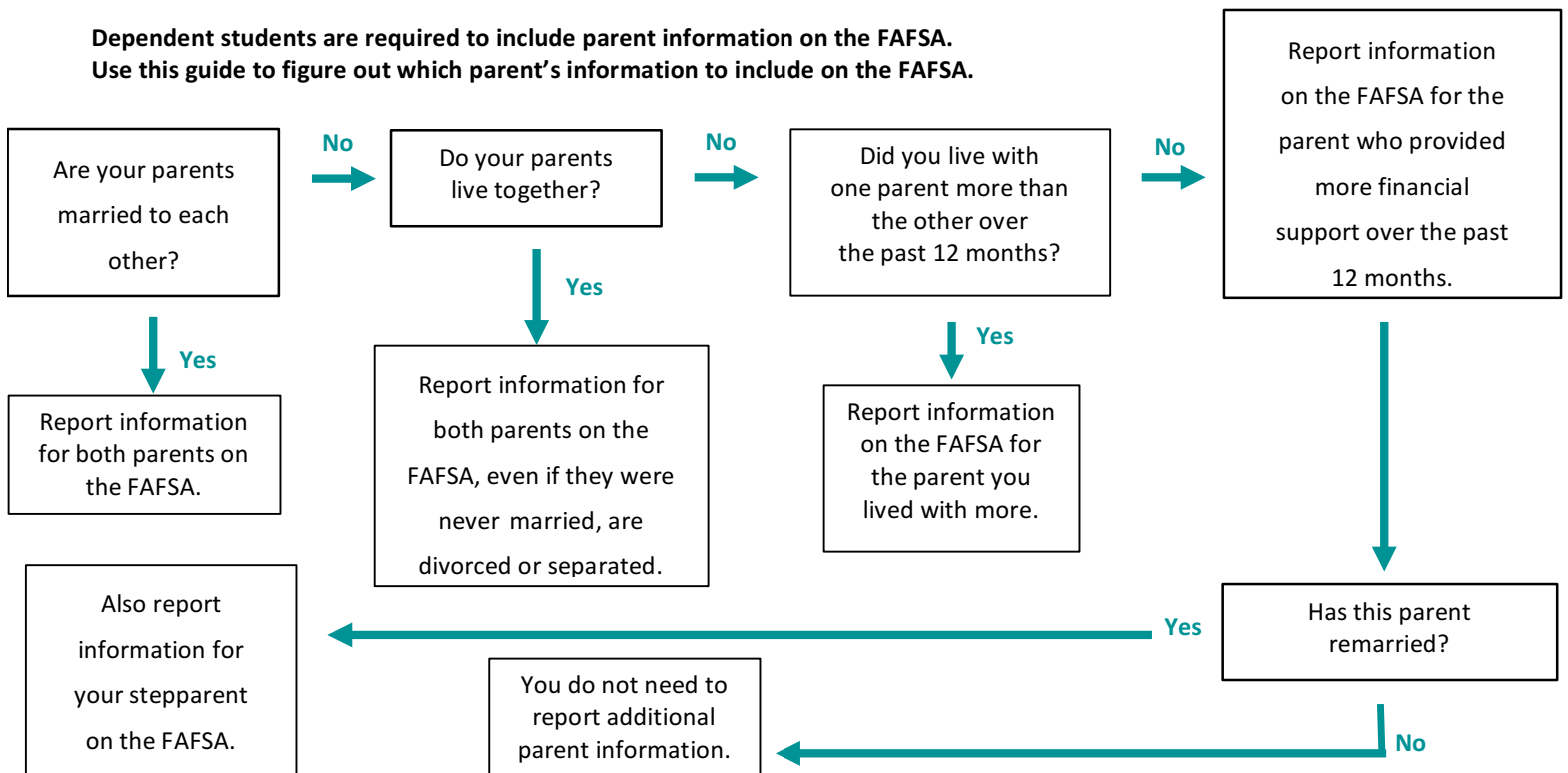
# What Is My Dependency Status?
