I understand the Veterans Affairs Coordinator receives periodic reports from the VA of educational benefit payments made to students. I further understand that if I receive benefit payments and I do not make reasonable and timely payments towards my tuition and fees that my total tuition and fees may become due with in seven days notice;

I understand that my eligibility for deferments under TCA section 49-7-104 may terminate if I do not follow the applicable rules and regulations or otherwise fail to act in good faith with timely and reasonable payment(s) of tuition and fees;

I understand I am responsible for making separate arrangement for tuition and fees that exceed the amount eligible for deferment;

I understand I am responsible for all books and fees, including digital course material that is automatically added to my account.
