Nashville State is committed to providing comprehensive educational programs for our over 10,000 students. In order to monitor the achievement of our students in relation to our mission, several criteria were selected for the evaluation of student success (see table 4.1 above). Thresholds are established by comparison to National median values, sister institutions in Tennessee, standards set by program accrediting bodies, or set by Nashville State Faculty as appropriate. A description of each achievement criterion, how it pertains to the mission, and how the threshold of achievement was set can be found by clicking on the threshold in each row in table 4.1. Judgement as to whether or not the established threshold was met on an annual basis for each criterion can be found in column three in table 4.1. Outcomes of data analysis are distributed to the campus community and are used to drive initiatives in annual strategic planning at all levels of the college in concurrence with the 2015-2025 Nashville State strategic plan.

Nashville State provides programs intended for technical certificates, preparation for the workforce, and

preparation for transfer to four-year institutions. It is important to the college that assessment tools span all students and not just a subset.
